# **Revised Paediatric Sepsis Clinical Pathway Factsheet**

#### Background

Sepsis represents a leading cause of preventable death and persistent harm for children in Queensland. An evidence based Paediatric Sepsis Clinical Pathway was implemented in 16 HHS Emergency Departments (ED) in Queensland and 80 rural and remote sites as part of the <u>Clinical Excellence Sepsis Breakthrough</u> <u>Collaborative Project</u> in 2019/2020

Many advancements have since been made including:

- an 18-month trial in 2020/2021 piloting a Paediatric Sepsis Inpatient Pathway in 8 paediatric wards across the state
- the development of a <u>Sepsis Clinical Care</u> <u>Standard</u> to improve the standards of care across the country and
- ongoing feedback from consumers wanting consistent information and support throughout their sepsis journey.

To meet these needs, the Pathway has been revised to extend beyond the acute resuscitation and treatment bundle into a sepsis management plan now covering the whole sepsis episode from presentation to discharge home.

# About the revised Paediatric Sepsis Pathway

The revised Paediatric Sepsis Pathway is based on international best practice and incorporates input from a broad range of paediatric experts and consumers across the state.

The ED Tertiary and Secondary, ED Rural and Remote and Paediatric Sepsis Inpatient Pathways have now been combined into one single pathway that is suitable regardless of location. Newly included in this paper pathway:

- monitoring and reassessment guide
- comprehensive management plan
- information sheet for parents and carers of a child diagnosed with sepsis

Updated content includes:

- screening and recognition tool
- antimicrobial guidelines
- sepsis checklist for families

The revised Pathway has been reviewed and evaluated by an independent human factors expert to ensure clarity, usability, and alignment with the national Sepsis Clinical Care standard.
